### **Lodging Tax Collection Update**

The fiscal year 2024 lodging tax collection through January are reporting Miller Small at an increase of 7.94% and Miller Medium is at an increase of 47.77%

Combined all three counties, Camden, Miller, and Morgan are reporting an increase of 8.96%.
