**1. Call To Order**

Business District Chair Brian Nivert called the meeting of the Lake of the Ozarks Area Business District of Morgan County Advisory Board to order at 1:02 p.m. A roll call attendance for the Advisory Board meeting was taken:

(A.) Approval of the Funding Disbursement Report #329 – The Morgan County Funding Disbursement Report #329 was presented for review, with no questions Brian Nivert made a motion to approve funding disbursement report #329. John Custer seconded the motion. The motion passed unanimously.

## **(B.) Sponsorship/Funding Request**

Missouri's Best Red-Carpet Event & Porsche Races - Missouri's Best Red-Carpet Event & Porsche Races – Cheri Cranford with Missouri's Best Magazine presented the funding request for Missouri's Best Red-Carpet Event & Porsche Races. This is the 8<sup>th</sup> year for the event. The event is to take place at the Ozarks International Raceway in Gravois Mills. The Red-Carpet event is scheduled for Thursday, April 25. Friday, Saturday, and Sunday, April 26 – 28, 2024, will be the Porsche races, with 150 drivers currently from the Kansas City Porsche Club to participate. Friday night will also host a music festival with three different bands. The Versailles Sonic Car Club will also be in attendance during the Porsche Races. Participates of the event will need lodging options all over the Lake area. Brian Nivert made a motion to approve \$5,000 to fund Missouri's Best Red-Carpet Event & Porsche Races. John Custer seconded the motion. The motion passed unanimously.

OAXC Racing Series – MOTO LOTO – May 4 – 5 – Christy Callahan with LOTO Offroad presented the OAXC Racing Series scheduled for May 4 and 5, 2024 request. This is a side-by-side racing event, which is what usually takes place at LOTO Offroad. This is the first year for the event to take place. Saturday, May 4, will have two and a half hours of racing with other offroad side-by-side events scheduled for the remainder of Saturday and all-day Sunday. John Custer inquired to the number of entries, there are some at this time, however it is unknown of the number that will attend. Christy stated that the individuals interested have been looking for larger places to stay then at LOTO Offroad, this should be a good opportunity for local lodging facilities in the area. John Custer made a motion to fund \$7,500 for the OAXC Racing Series – MOTO LOTO. Brian Nivert seconded the motion. The motion passed unanimously.
